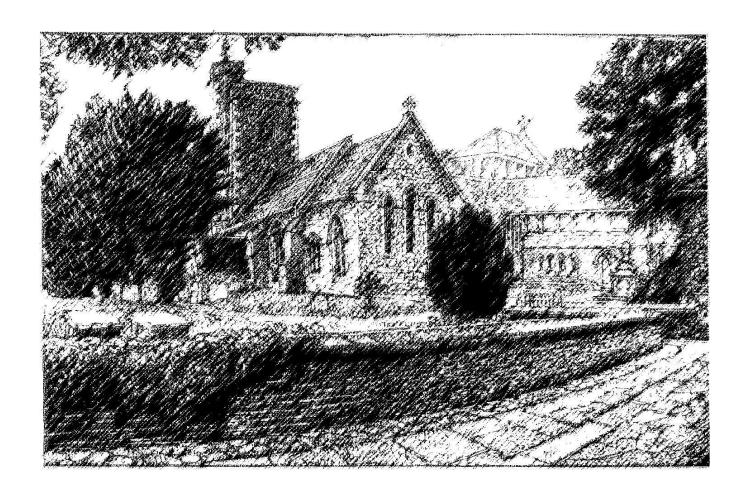

The Annual Parochial Church Meeting 2020

Under the revised Church Representation Rules, the stewards will be appointed at the next PCC meeting on 11 May.

The written report on proceedings of the PCC in the Annual Report was received.

Report on the annual accounts

In 2019, the gain on investments was £12,000; there was an anonymous grant of £10,000; earnings from Kitson Hall produced almost £30,000; the Friends' surplus on events was £58,000, and £22,000 was given to charity. There was a disappointing response to an appeal during the interregnum. However, a responsible level of spending meant that we were able to record an overall surplus of £48,709.

2020 was affected by the pandemic almost all year, so very little collected at services -just over £10,000, (just over £30,000 in 2019), but a generous response to an appeal saw bank gifts rise from £116.000 to £132,000. Overall income dropped from £474,000 to £396,000. Luckily, expenses also fell from £438,000 to £396,000. There was almost no capital spending at all, either in Church or Hall.

The main features of 2020 were receipt of £28,000 from Boileau Road, net £19,000 from the Charity Ball and £7,000 gain on investment. Kitson Hall managed £9,000 profit, which was transferred to the Youth Fund. We benefitted by £17,000 from the Job Retention Scheme. The overall surplus on Friends' events was £36,000, of which £13,000 was given to charity.

The future is 'cloudy'. There are large amounts to spend on capital works both in Church and Hall, but giving remains encouraging, and we hope to be back to normal service by 1 October. The large decision to be made following the hopefully successful sale 52 Boileau Road, is to how we deal with the cash proceeds.

There was a question about whether not having a house available made a request for a Curate less likely to succeed. The Treasurer said that it was the contrary, as we will be able to find suitable accommodation for whomever is appointed rather than expecting one house to suit everybody. Another comment requested that the proceeds from Boileau Road should be put into a restricted account, and that the sale of the Team house (not initiated by St Mary's) further weakened the Team. The Rector replied that the PCC would be taking a decision about the use of proceeds but that he would wish to see them restricted to generate income to enable the parish to house a curate or support others training for ministry in the future. He added that the intention is to strengthen the team by enabling Holy Trinity to use its share to advance its mission aims, and to explore new avenues for collaboration free of the burden of managing a property.

Alastair Cameron was appointed as independent examiner of the accounts for 2021, proposed by Judy Gowing, seconded by Peter Boyling.

The written reports on the fabric of the church, and of the church hall in the Annual Review were received. Thanks were extended to Peter Boyling and William Heller and all who work with them.

The written report on the <u>Team Council</u> in the Annual Review was received.

The written report on <u>Deanery Synod</u> in the Annual Report was received.

The Rector pointed out that anyone on the electoral roll is eligible to attend Deanery Synod meetings. There are often interesting discussions. Watch out in Weekly News for announcements.

Notes on the Rector's reflection

First, a huge thank you to all for the way the church family has maintained and enhanced the life of the parish during the pandemic. James also said how grateful he is for the support given to Alice, the family and him since moving to Barnes.

John 15:1-5. Essential that we always keep Jesus the true vine as the centre of our church life and recognise our fellowship together as branches of that vine.

After Covid, we cannot assume church life will just bounce back as before. Habits of churchgoing and of faith may well have been lost in lockdown, and so will need support in re-forming and nurturing afresh. Some ways in which we can do this include:

- work with families. Jackie and Julie have done all they can, but it will be so much better to have renewed face to face contact with groups. The new toddler service on a Tuesday morning will start after half term in June as a new way of engaging with that demographic;
- care for creation is the key global issue post-pandemic, with the General Synod commitment to net carbon zero by 2030. I am excited at how the environment group has developed, cutting across all aspects of church life and in living out our faith personally and in the community.
- Welcome. We formed the Welcome Group in the wake of the death of George Floyd. While St Mary's is indeed a welcoming place for many, we must always look at how this may not seem quite the same for others. The group can help us attract others to our life together who have been excluded through race, gender and sexual orientation and disability. The communications group is planning a new welcome video for the website.
- Communications. It was fortuitous that we had already formed the communications group before Lockdown, and this has played a big role in transforming how we communicate internally and externally. Live-streaming equipment will be installed soon, and the website has just been refreshed. We must not forget our online congregation.
- Deepening faith and vocations. It would be good to have a curate, but we should be a parish which is growing vocations and exporting people to ministry elsewhere, not relying on importing! We have people with many God -given gifts, so there is much potential, but it will be a challenge. Developing the new monthly Sunday evening service with a team of leaders from the congregation is one example of seeking to address this.
- Looking outwards. We need to be adept at being alongside others as they respond in different ways to recovering from lockdown. The Barnes Fund research will help us identify how best to support those in need locally. And charity may begin but should not end at home. Barnes has had a much easier experience of the past year than many, so we must not be Parochial!

The Rector ended with quoting John 15:1-5 again and urged us to seek to abide in Christ in all we do as we go forward.

THE PAROCHIAL CHURCH COUNCIL

The PCC meets eight times a year chaired by the Rector, with Peter Boyling as Vice-Chair.

During the pandemic, the Council continued to meet but virtually via Zoom.

The meetings receive reports about finance, fabric, safeguarding, Kitson Hall, Deanery Synod and Faith in Action. Since the last APCM, groups looking at Communications, Environmental issues and Welcoming have been formed and they too supply information to the PCC.

The PCC annually reconsiders our contribution to the Parish Support Fund, whether a Stewardship campaign is required, how best to implement our Mission Action Plan, protocols for Disciplinary, Grievance and Complaints, Safeguarding and reviews staff salaries. Other business undertaken and decisions made by the PCC will be covered in other reports.

DEANERY SYNOD

St Mary's is in the Deanery of Richmond and Barnes which follows the south bank of the Thames from Hammersmith Bridge to Ham, covering 15 parishes. St Mary's lay representatives are Phil Bladen, Annie Sullivan and Judy Gowing, with Revd James in the House of Clergy. We are entitled to have 5 lay representatives. The Synod meets three times a year and is a conduit between the parishes and the Diocese, and up the chain of the Church of England.

Rev'd Peter Hart, who was the Area Dean, has moved and been succeeded by Revd Alex Barrow, the vicar of All Saints, East Sheen.

The meetings are interesting and open to everybody. Discussions over the past two years have covered communications, safeguarding, diversity and knife crime. As a deanery, it was decided to fund a Knife bin to be sited in one of the worst areas of the Diocese for knife crime. This is just one example of how the area can benefit from the churches working together as a Deanery.

HONORARY TREASURER'S REPORT FOR YEAR ENDING 31st DECEMBER 2021

This is my twelfth, and last, report on the PCC's accounts. Tempting as it is to reminisce, I do not intend to dwell on all the vicissitudes of those years and will concentrate on what happened in 2021.

We came into the year nervously, with Covid still very prevalent, and anticipating a considerable shortfall in funds (perhaps £30,000 plus) for the year. This did not happen, for a number of reasons:

- Overall giving was £12,000 above forecast, and £15,000 above 2020.
- There was much greater income than anticipated from the bicycle sale, weddings/funerals and hire of the church.
- Our investment in the CCLA Charities Fund grew by another £12,000.
- The government Job Retention Scheme lasted longer than we had expected and contributed a further £14,000.

The General Fund, which holds our basic reserves, therefore grew to £120,000 (one reminiscence, it was £101,000 in 2010).

Despite the considerable obstacles to its operation, the Kitson Hall still managed to record a £11,000 surplus, which allowed us to supplement the Youth Fund by this amount, and the Friends, although unable to hold a Charity Ball, also managed to record a decent surplus from the Charity Fashion Show and a number of smaller events.

Over the 12 years I have been indebted to several people for help without which the accounting function would have collapsed round our ears. Three Gift Aid Secretaries (Chris Hine, John Harries and Michael Murison) have rescued about £400,000 from HMRC; Vic Nolan, followed by Richard du Parcq, looked capably after the banking of our funds, and Tiziana George throughout that time has supplied the brilliant organisation as Bookkeeper which I so notably lack, and has never spoken a cross word to me. I thank them all for the last time. I must also thank Michael Ross-McCall for agreeing to take on the job (subject to PCC approval, which I would be surprised, were it not forthcoming). It is not an inconsiderable one.
