Note 4: Represent the net sale proceeeds from Boileau Road in 2021 which are currently "ring fenced" to finance the specific costs of people in ministry - currently the Associate Priest but could include others in the future if we choose.

Note 5: The PCC has recommended retaining cash reserves of at least £260,000 (excluding Endowment fund / investments) to cover expected and possible future expenditures; there was a cushion of £42,465 as at 31/03/23.
